Paul V. Koffman, age 65 of Albia, died Thursday, April 10, 2008, at the Monroe County Hospital in Albia.

Paul then attended Iowa State University for a short time before an automobile accident caused him to leave school. Paul married Dorothy Jane Lewis on February 28, 1970, at St. Mary's Catholic Church in Albia. To this union six children were born.

Paul farmed all his life, and was the owner and operator of Koffman Amoco in Albia. He also worked at the Albia sale Company. Paul was currently an elected Monroe County Supervisor and chairman. Paul was in his 16th year of service to Monroe County. He served on many local, district, and state committees throughout his 16 year career.

Paul enjoyed fishing, and teaching his grandchildren how to fish. He also enjoyed his children's and grandchildren's sporting events. Paul was a member of and past parish president of St. Mary's Catholic Church and past president of the Knights of Columbus council #4167 and an active member of the Knights of Columbus 4th degree assembly #1925, the Monroe County and Iowa Cattlemen's Association, and was active in the Monroe County

Democratic Party. Paul was former 4-H leader, Moravia School Board Member, and also worked on the Farmers Home Administration Board.
